GENERAL INFORMATION

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water posed a health risk. SOURCE WATER ASSESSMENT INFORMATION

The Perry water supply obtains a portion of its water from the sand and gravel of the North Raccoon River alluvial aquifer and a portion of its water from the sand and gravel of the Pleistocene aquifer. The alluvial aquifer was determined to be highly susceptible to contamination because the characteristics of the aquifer and overlying material provide little protection from contamination at the land surface. The Pleistocene aquifer was determined to be slightly susceptible to contamination because the characteristics of the aquifer and overlying material provide little protection from contamination at the land surface. The Pleistocene aquifer was determined to be slightly susceptible to contamination because the characteristics of the aquifer and overlying material provide moderate protection from contaminants at the land surface. Perry's alluvial wells will be highly susceptible to surface contamination such as leaking underground storage tanks, contaminant spills, and excess fertilizer application.
